Q1 2024 FUM based revenue and member based revenue include an incremental impact from the QuayStreet acquisition (which occurred on 23 February 2023) estimated at \$1.23m and \$0.023m respectively. FUM based revenue also increased due to synergies unlocked in the ASB SMT transition services migration completed in August 2023.
